Who is providing this document?	<p>You are receiving this notice from SingUnited International (SU), a worldwide women’s singing organization committed to advancing the musical art form of barbershop harmony through opportunities in education, performance, and competition.</p>	
Why this Summary?	<p>As a Membership organization, SingUnited International collects some of your personal information data. You have a right to consent to our data collection. You have a right to know that we collect, share, and protect your information.</p>	
What information does SU collect or share?	<p>We collect personal information based on your consent to provide member services to you. The information may include:</p> <ul style="list-style-type: none"> • Name, address, telephone number; • We also collect credit card information when you pay your membership dues (we do not share credit card info); • We also collect credit card information when you pay for a merchandise purchase (we do not share credit card info); • We share your address information to mail you the <i>Pitch Pipe</i>. 	
How does SU collect and share your information?	<p>With your consent, we collect your information primarily over the phone, via our website, via email, or face-to-face. We share your address information between our Chapters, Regions, Headquarters and some third-party vendors in order to provide member services to you. If you are a <i>new</i> member, we begin sharing your information within 30 days from the date we send this notice. When you are <i>no longer</i> a member, we continue to process your information for historical purposes only.</p>

Summary of SingUnited International use of your personal information and data

Basis for Obligation to Provide Data	The provision of your personal data is based only on a requirement of membership in order to facilitate our maintenance of membership records. We do not intend to process your information for any other purpose.
Data Storage	We maintain your data as long as possible in order to facilitate our internal evaluation of membership trends.
How does SingUnited collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> • Enroll or renew as a member; • Make a purchase via our website or over the phone; • Use your credit or debit card
How does SingUnited protect my personal information?	We protect your information by limiting sharing. Your data is primarily used only by SingUnited International, Chapters, Regions, and/or Quartets via our database. To protect your personal information from unauthorized access and use, we use multiple security measures. These measures include computer safeguards and secured files and buildings. International Transfer	Your data may be collected by a Chapter in the European Union and then input into our database, which is maintained in the United States and accessible by other Regional and Chapter leaders in other countries.

Affiliates	SingUnited International, Chapters, Regions, and Quartets.
Non-affiliates	Organizations not related by common ownership or control. <i>Non-affiliates we share with can include printers which facilitate PitchPipe distribution; website and database processor providers, survey facilitators, etc.</i>
Joint marketing	Non-affiliated organizations that together market products or services to you through our <i>Pitch Pipe</i> or website. <i>Includes exhibitors, sponsors, and other barbershop organizations, often in relation to International Convention & Competition.</i>
